## Provider Network

Youth and families enrolled in Wraparound Milwaukee have access to the Wraparound Provider Network. The Provider Network includes agencies who provide high quality youth and family-focused mental health care and other services.

Services may include:

- ✓ Crisis Services
- ✓ Individual & Family Support Services
- ✓ Individual & Family Therapy
- ✓ In-Home Treatment
- ✓ Medication Management
- ✓ Substance Abuse Counseling
- ✓ Out-of-Home Care: If identified on the court order, this may include foster care, group home or residential placement

Community supports may include:

- ✓ Mentoring
- ✓ Tutoring
- ✓ After School programs
- ✓ Special Camps

## Wraparound

---

Wraparound Milwaukee provides coordinated community-based supports and services to families of youth with complex emotional, behavioral, and mental health needs. Funded by the State Medicaid Division, Division of Milwaukee Child Protective Services and/or Milwaukee County Delinquency and Court Services Division.

Wraparound Milwaukee utilizes the Wraparound process, which is a strength-based and individualized approach of service delivery that is based on families identifying what support they need to care for their child in their home and community.

Wraparound Milwaukee promotes family independence by acknowledging that families or caregivers know what is best for their youth and family. Families are provided with a Care Coordinator who partner with them to identify and coordinate personal, community, and professional supports to meet needs, teach skills, and to “wrap” those supports around the youth and family. A team of support offers targeted help that promotes healing and leads to hope for a better future as defined by the family.

## Eligibility Criteria

---

- ✓ Youth and family voluntarily want the support and services
- ✓ Mental Health Diagnosis as defined by DSM-V
- ✓ Has been involved in mental health services and one or more service systems such as special education, child welfare, or juvenile justice
- ✓ At risk of out-of-home placement
- ✓ Current Delinquency, CHIPS, and/or JIPS Order
- ✓ Eligible for Medicaid or the BadgerCare Program
- ✓ Youth must reside in Milwaukee County, along with their Medicaid eligibility
- ✓ Experiencing mental health challenges for at least six (6) months and be expected to persist for a year or longer

## Program Benefits

---

Program benefits, in addition to Care Coordination, include:

### **Family Advocacy**

Care Coordinators can connect families to Family Advocacy services for opportunities to link with other parents/caregivers who have had similar experiences.

### **Educational Advocacy 414-257-6799**

The Special Education Advocacy (SEA) Group provides advocacy within the school system. The SEA Group can help families work with their youth’s school district to get needed services, as well as assisting in the Individualized Education Plan process.

### **Children’s Mobile Crisis 414-257-7621**

Youth enrolled in the program and other youth in Milwaukee County who are experiencing a mental health or behavioral health crisis or at risk of psychiatric hospitalization can access the Children’s Mobile Crisis Team, which is available 24 hours a day, 7 days a week to provide crisis intervention services.
